DEPOSIT AND ADMINISTRATIVE FEES: \$1,500.00 (ONE-THOUSAND FIVE HUNDRED) USUALLY SPLIT \$750.00 (SEVEN HUNDRED AND FIFTY DOLLARS) FOR EACH PARENT UNLESS OTHERWISE STIPULATED AND DUE BEFORE FIRST SESSION.

DEPOSIT: \$1,000.00 (ONE THOUSAND DOLLARS) THESE FEES COVER CONVERSATIONS WITH ATTORNEYS, REPORTS TO THE COURT, WRITING OF ORDERS, AND WORK IN ADDITION TO THE SESSIONS WITH PARENTS AND/ OR CHILD REQUIRED OF THE SPECIAL MASTER. THIS FEE MAY BE PAID BY GOING TO WEBSITE: MROSENMFT.COM UNDER 'MAKE A PAYMENT' OR IN PERSON BY CASH OR MONEY ORDER. CHECKS OTHER THAN THOSE WRITTEN BY ATTORNEYS ARE NOT ACCEPTED.

ADMINISTRATIVE FEE: \$500.00 (FIVE-HUNDRED DOLLARS) THESE FEES COVER: ONE-TIME CHARGE FOR SETTING UP FILE, REVIEW OF ALL COURT FILES INCLUDING CHILD CUSTODY EVALUATIONS, DECLARATIONS, AND OTHER RELEVANT DOCUMENTS.

HOURLY RATE: \$160.00 (\$80.00 EACH PARENT-TO BE PAID AT THE BEGINNING OF EACH SESSION BY USING SPECIAL MASTER'S WEBSITE WHERE CREDIT AND DEBIT CARDS ARE ACCEPTED OR IN PERSON WITH CASH OR MONEY ORDER, CHECKS OTHER THAN BY ATTORNEYS ARE NOT ACCEPTED).

REFILLABLE RETAINER: \$560.00 (For fees and costs – must be refilled as expended.) (To be applied to any outstanding balance at the end of the PPC's term, with the remainder refunded to the payer.)

1. The parent requiring the PPC's testimony shall deliver (by fax, mail, or other delivery) a subpoena to the PPC's office during regular business hours. The PPC shall accept subpoenas delivered to the PPC's office, and waive personal service.
2. **EXPERT TESTIMONY AND DEPOSITION FEES:** Court appearances are charged in four (4) hour segments; morning (8:30AM-Lunch) or afternoon (after Lunch-4:30PM) as required. There is a minimum charge of \$1,600.00 (ONE-THOUSAND SIX HUNDRED DOLLARS) for testimony in each segment regardless of length. THIS EQUALS \$400 AN HOUR WITH A FOUR HOUR MINIMUM AND INCLUDES TRANSPORTATION AND REVIEW OF FILES. THE SAME FEE IS CHARGED FOR A DEPOSITION.
